Bridal Booking Terms & Conditions

1. Booking & Trial Appointments

Booking a Trial

- It is recommended to schedule your trial at least two weeks before your wedding.
- Trials are conducted on weekdays between 09:00 and 16:00 at my home studio in Durbanville.
- No trials are available on Fridays or weekends.
- Trials typically take 2 to 3 hours.
- Please provide three possible dates for your trial, and I will confirm availability.

Trial Day Guidelines

To ensure the best experience:

- Wear white or attire similar to your wedding dress.
- Bring any hair accessories, earrings, and, if desired, temporary lashes or lash extensions.
- If applicable, bring clip-in hair extensions for styling.
- Send reference images after booking your trial to help me understand your desired look.

Trial Attendance

- The bride should attend the trial alone to maintain focus and ensure a clear understanding of her desired wedding day look.

Rescheduling & Cancellations

- If you need to reschedule your trial, please provide at least 48 hours' notice. Late rescheduling may incur a fee.
- Cancellations within 72 hours of your trial date will result in the loss of the booking fee.

2. Wedding Day Services

Preparation & Timing

- Please arrive with a clean, makeup-free face and freshly washed, dry hair.
- I will provide a timeline for services to ensure a smooth and stress-free morning.

Additional Services

- The number of bridal party members requiring services (bridesmaids, mothers, etc.) must be confirmed at least one month before the wedding.
 - For large bookings, an additional hairstylist or makeup artist may be required, and an assistant fee may apply.

Early Start & Weekend Surcharge

- Early morning start times before 6 AM may incur an additional fee.
- Bookings on Sundays or public holidays may also have an additional surcharge.

3. Travel & On-Site Services

- A travel fee of R7.50 per km applies to locations outside Durbanville, subject to fuel price changes.
- Additional travel costs, such as toll fees, parking, or accommodation for destination weddings, will be covered by the client.

4. Payments & Booking Fee

Payment Terms

- Payments are accepted via EFT only (no cheques or cash deposits).
- If paying in cash or foreign currency, an additional administration fee may apply.
- A 50% non-refundable booking fee is required to secure your wedding date.
- The remaining balance must be paid in full one month before the wedding day.

Important Notes

- Once paid, the booking fee is non-refundable and non-transferable to other services.
- Payment of the booking fee confirms your acceptance of these terms & conditions.
- Payment details will be provided via email at info@claritasmit.co.za.

5. Cancellations and Refund Policy

- Wedding day cancellations made within 30 days of the booked date require full payment of the remaining balance.
- In the event of unforeseen circumstances (such as extreme weather, illness, or personal emergencies), I will make every effort to arrange an alternative artist/stylist. If no replacement is available, a partial refund may be considered at my discretion.

5. Liability & Agreement

- While I take every precaution to ensure a flawless experience, I am not liable for allergic reactions, sensitivities, or skin irritations resulting from makeup or hair products.
